



Anti-Doping Information Circular

Monaco, 25 June 2014

Dear all,

Recently, it is believed that there may have been several cases of athletes competing in events/ competitions during periods of ineligibility, following positive doping findings.

As such, and so as to encourage more communication between all concerned parties, it is felt appropriate to reprise the circulation of some basic – but essential – anti-doping information, by way of a regular update from the IAAF Medical & Anti-Doping Department to all AIMS Members.

This communiqué will provide you with a list of athletes currently serving a period of ineligibility (and known to mainly compete in distance races), as well as a second list of athletes who have returned an Adverse Analytical Finding and are therefore considered to be in a period of (at least) provisional suspension, but for whom we are not unequivocally certain have either i) been made aware of the finding, or ii) are choosing to ignore attempts to ensure such notification. In both instances – and from the perspective of race organisation – they should not be admitted to competition. In any such cases, race organisers are thereby requested to communicate such attempts to compete to us.

Additionally, it can be used as a means to distribute updates regarding amendments made to relevant technical documentation or expectations in respect of In-Competition testing, alongside new education materials and protocols; all of which you can find both via the IAAF Website, or request in hard copy to distribute at your event, or for your own awareness.
